## Short Summary

According to a VOA report ([6 December 12](#)), following the self-immolation of Penag Monastery monk Lobsang Gedun on the evening of December 3, 2012, public security officials in the seat of Guoluo (Golog) county, Banma (Pema) TAP, Qinghai province, detained Washul Dortrug later the same night. Police detained a second Tibetan man, [Choekyab](#) (or Lali Choekyab), the next day (December 4) when he went to the county PSB office to “urge Washul’s release.” The report described the men as “prominent Tibetans” regarded as “respected mediators in the local community.” Information is unavailable on their place of detention and whether officials regard them as associated with Lobsang Gedun’s self-immolation (see VOA, [3 December 12](#); Phayul, [5 December 12](#)). In March 2008, police detained Washul Dortrug in connection with local protests; information on the length and results of his detention is unavailable.
