Short Summary

According to SMHRIC ([20 June 06](#)), officers at the Hohhot Intermediate People's Court in Hohhot, Inner Mongolia, detained Uiles and his mother [Xinna](#) on June 12, 2006, during the [trial](#) of Mongol doctor [Naguunbilig](#) and his wife [Daguulaa](#). Uiles and Xinna are son and wife of Mongol activist [Hada](#). After Xinna asked the court a question, officers intercepted them and placed them in custody for "disturbing court proceedings." Authorities reportedly beat Uiles. They ordered him to spend 13 days in detention at the Hohhot No. 1 PSB Detention Center. According to SMHRIC ([4 December 10](#), [8 December 10](#), [11 December 10](#), [27 December 10](#), [5 May 11](#), [8 July 11](#)) and RFA ([25 October 11](#)), officials took Uiles into custody on December 4, 2010, for "spreading the word through the Internet" about his family and released him that day before placing him in detention on December 5, in reported connection to Hada's scheduled release from prison on December 10. A detention notice accused Uiles of "being involved in drug dealing." Officials formally arrested him around January 17, 2011. He was held in the Hohhot No. 3 PSB Detention Center and released on bail pending trial around October 2011.
